As the development of these resources continues, more and more capacity is gained, which will allow the First Nation to maximize their investment of their own resources moving forward." It is with this spirit in mind that Mr. Buffalo believes that, "IRC must also ensure that the Federal Government is supporting, and working with, First Nations to maximize the potential benefits of their natural resources. The big picture shows First Nations becoming more of an active player in all areas of resource sector, from providing certain services all the way to equity ownership. For this to happen we need heightened communication, more capacity building and more support systems in place."

As IRC's new leader, Mr. Buffalo concludes the conversation by speaking to the firm vision he already in place for the organization, "My vision is to continue to work with the members of the IRC, to maintain a strong relationship with Indian Oil and Gas Canada (IOGC) and to work together on our mandates to ensure that First Nations are protected and maximize their benefit on their natural resources. Looking ahead the sky is the limit."


